In exercise of the powers vested in me under sub-section (1) of Section 11 of the Goa Municipalities Act, 1968 amended from time to time, I, P. M. Borkar, Commissioner, Goa State Election Commission, Panaji, hereby notify that the electoral rolls of the Goa Legislative Assembly prepared under the provisions of Representation of People Act, 1950 and for the time being in force as on 1st June, 2010 for such constituency of the Assembly or any part thereof as is included in the Municipal areas shall be divided into different sections corresponding to different wards of the Municipal Councils of Pernem, Mapusa, Bicholim, Valpoi, Margao, Cuncolim, Mormugao, Sanguem, Quepem, Curchorem-Cacora and Canacona as may be fixed by the Director of Municipal Administration under Section 10 of the Goa Municipalities Act, 1968.

The division of electoral rolls into different sections corresponding to different wards shall be done by the Mamlatdars of the respective Talukas in which the Municipal Councils are situated and the lists of votes so prepared shall be authenticated by the Dy. Collector & S.D.O's of the concerned sub-divisions.
