Land Acquisition for construction of internal road near Vaddem Lake in Vasco Constituency.

Whereas by Government Notification No. 23/52/2008-RD dated 17-12-2008 published on pages 977 & 979 of Series II No. 40 of the Government Official Gazette, dated 08-05-2008 and in two newspapers (1) "Navhind Times" dated 21-12-2008 and (2) "Goa Doot" dated 21-12-2008, it was notified under Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as "the said Act"), that the land specified in the Schedule appended to the said Notification (hereinafter referred to as the said land), was needed for the public purpose viz. Land Acquisition for the const. of DWC 5R, 6R & 6R (A) of Sal Distributory of L.B.M.C. of T.I.P. at Salem Village in Bicholim Taluka.

And whereas, the Government of Goa (hereinafter referred to as the "Government") being of the opinion that the acquisition of the said land is urgently necessary, hereby applies the provisions

of sub-section (1) of Section 17 of the said Act and directs that the Collector appointed under paragraph 2 below, shall, at any time, on the expiry of fifteen days from the date of the publication of the notice relating to the said land under sub-section (1) of Section 9 of the said Act, take possession of the said land.

Now, therefore, the Government hereby declares, under the provisions of Section 6 of the said Act that the said land is required for the public purpose specified above.

2. The Government also hereby appoints, under clause (c) of Section 3 of the said Act, the Special Land Acquisition Officer (N), G.T.I.D.C., Karaswada, Colvale Road, Bardez-Goa to perform the functions of the Collector for all proceedings hereinafter to be taken in respect of the said land and directs him under Section 7 of the said Act to take order for the acquisition of the said land.
