Sub.: "Financial Assistance for purchase of fuel (kerosene/petrol) to the fishermen for operation of Out Board Motors".

The Government of Goa is hereby pleased to introduce the scheme for granting financial assistance for purchase of fuel to the fishermen for operation of Out Board Motors.

1. Short title and commencement.— (a) This scheme may be called "Financial Assistance for purchase of fuel (kerosene/petrol) to the fishermen for operation of Out Board Motors".

(b) It shall come into force w.e.f. 1st December, 2012.

2. *Introduction.*— Fishing is one of the prime industries of the State and it is only source of livelihood of sizable community of traditional

fishermen who have been contributing significantly to the fish production of the State. These fishermen have been facing hardship in getting a regular supply of fuel (kerosene/ /petrol) in the absence of any special quota allotted to this industry.

Over the past few years these fishermen are also undergoing economic strains due to over rising cost of the fuel i.e. petrol & kerosene as well as the depletion of fish catch. There has been a persistent demand from these traditional fishermen to provide them subsidize fuel (kerosene/petrol) for their Out Board Motor at subsidized rates. Therefore it is proposed to grant financial assistance for purchase of fuel (kerosene/petrol) to the fishing canoe fitted with Out Board Motor of the State of Goa through the network of Registered Association/Societies of the fishermen.

3. Objective.— The main objective of the scheme is to provide financial assistance for purchase of fuel (kerosene/petrol) in order to grant relief to the traditional fishermen to overcome the financial losses suffered by them on account of non-availability of kerosene in the State and due to ever increasing cost of the kerosene so as to enable them to sustain themselves.

This scheme thus designed to support fishing industry in the State of Goa and grant financial assistance for purchase of fuel (kerosene/petrol) consumed by them for the purpose of fishing activities.

4. Eligibility conditions.— (a) The fishing canoe should be registered under the Goa, Daman & Diu Marine Fishing Regulation Act, 1980 (Act No. 3 of 1981) and rules framed thereunder.

(b) Should be member of Registered Fisheries Co-operative Societies/Associations.

(c) Should possess a valid net license and fishing license for the year.

(d) Shall not be a defaulter of the Directorate of Fisheries.

(e) Shall not be a violator of the Goa, Daman & Diu Marine Fishing Regulation Act, 1980

(Act No. 3 of 1981) and rules framed thereunder.

(f) The Vessel Registration Certificate of the canoe must have the OBM incorporated on it.

5. Terms of sanction.— (i) In case the applicant is using kerosene OBM than he/she shall produce a certificate of actual consumption of kerosene issued by G. R. E./ /Registered Fishermen Association. A register shall be maintained by the respective Co-operative Society/Associations recording the monthly consumption of the kerosene by individual member which will be verified by the authorized officials of the Department.

(*ii*) In case the applicant is using petrol OBM than he/she has to produce VAT bill/Voucher from authorized petrol pumps duly countersigned by G. R. E./Registered Fishermen Association/Society.

(*iii*) The fishing vessel/canoe and Out Board Motor shall exclusively be used for fishing activities only.

(*iv*) The subsidy amount shall be disbursed in favour of the applicant in his/her account through ECS mode of payment.

(v) Only OBM having 10 HP or below will be eligible for subsidy.

(vi) Subsidy shall be granted for the consumption of fuel i.e. petrol/kerosene for the period, from the month of August to May only.

6. *Quantum of Subsidy.*— The Fishermen using kerosene OBM shall be eligible for subsidy upto a maximum of Rs. 50,000/-(Rupees fifty thousand only) as follows:—

Quantity of kerosene consumed	Rupees
(1) 2000 litres	50,000/-
(2) 1500 to 1999	37,500/-
(3) 1000 to 1499	25,000/-
(4) 500 to 999	12,500/-

Fishermen using Petrol OBM shall be eligible for subsidy of Rs. 30/litre on a maximum consumption of 1200 litres of Petrol. Midyear shifting from Kerosene to Petrol is permitted on pro rata basis and once shifted cannot claim Kerosene subsidy again in future i.e. route of claim to petrol is one way route only.

7. Budget.— The required Budget provision shall be provided by Directorate of Fisheries under the Budget Head: "2405—Fisheries; 103—Marine Fisheries; 08—Financial Assistance towards Subsidy for Kerosene/ /Petrol (plan); 33—Subsidies; under Demand No. 66".

Sub.: "Replacement of old kerosene OBM to Petrol OBM".

The Government of Goa is hereby pleased to introduce the scheme "Replacement of old kerosene OBM to Petrol OBM for operation of fishing canoe".

1. Short title and commencement.— (a) This scheme may be called "Replacement of old kerosene OBM to Petrol OBM for operation of fishing canoe".

(b) It shall come into force from the year 2013-14.

2. Introduction.— Fishing is one of the prime industries of the State and it is only source of livelihood of sizeable community of traditional fishermen who have been contributing significantly to the fish production of the State. Over the years the fishermen are finding it very difficult to manually operate the fishing canoes and are now fitting Out Board Motors to ease them from manual operation as it saves the time to go to & fro to the fishing grounds. This helps in reducing the post harvest losses also.

Due to non-availability of kerosene in the State it has become difficult for the traditional fishermen to operate the fishing canoes fitted with kerosene Out Board Motors. It is proposed to replace old kerosene OBM to petrol OBM. The cost of the Petrol Out Board Motors is very high and the fishermen are not able to afford to purchase the same. Therefore it is decided to provide them subsidy on replacement of old kerosene OBM to petrol OBM. It is also proposed to provide them a 2-stroke/4-stroke Petrol OBM which is environmental friendly and consumes less petrol. Further there will also be savings on subsidy on purchase of petrol @ Rs. 14,000/- (Rupees fourteen thousand) per OBM against kerosene.

3. *Objective.*— The main objective of the scheme is to provide subsidy on the replacement of old kerosene OBM to petrol OBM.

4. *Eligibility conditions.*— (1) The beneficiary should possess a registered fishing canoe.

(2) The OBM to be replaced through the scheme should have been incorporated on the registered fishing canoe.

(3) The canoe should be in operational condition.

5. Terms of sanction.— (1) Prior NOC from the Department to be obtained before purchase of OBM.

(2) The Out Board Motor purchased should have a Horse power of 10 Hp or below.

(3) The applicant shall not sell, lease mortgage or transfer the Out Board Motor for a period of five years from the date of purchase of the said OBM. (4) The Out Board Motor purchased shall be operated exclusively for fishing purpose only.

(5) In case the OBM is purchased by the beneficiary, he/she shall submit the original bill from authorized dealer to claim the subsidy.

(6) The subsidy amount shall be disbursed in favour of the applicant in his/her account through ECS mode of payment in case the OBM is purchased by the beneficiary.

(7) The Department also reserves the right to purchase the OBMs and supply to fishermen on deposit of Rs. 30,000/- (Rupees thirty thousand) plus 2% of the cost of the engine.

(8) The OBM procured shall be incorporated in the VRC of the canoe.

6. Quantum of Subsidy.- Amount of subsidy to be paid is 98% under the scheme. However as Kerosene Engines were purchased by Fishermen from Government Subsidy and as the same was now to be replaced, the old Kerosene Engine has to be returned to the department. Thus the scheme is an upgrading of the Engines from Kerosene to Petrol. The value of subsidy for Kerosene engine were Rs. 30,000/- (Rupees thirty thousand) during earlier years and therefore to avoid the task of disposing of so many old kerosene engines, the subsidy was to be reduced by Rs. 30,000/- (Rupees thirty thousand) and the Canoe Owner be allowed to keep the engines or dispose the same as deemed fit by him.

The 98% subsidy on the 2-stroke/4-stroke engine shall be provided on payment of Rs. 30,000/- (Rupees thirty thousand) and 2% towards the cost of new engine.

In case the OBM is purchased by beneficiary from authorized dealer an amount of Rs. 30,000/- (Rupees thirty thousand) shall be deducted and 98% of the cost of engine shall be given subsidy limited to a maximum of Rs. 2.15 lakhs (Rupees two lakhs fifteen thousand) per OBM in case of 4-stroke petrol OBM and Rs. 1.30 lakhs (Rupees one lakh thirty thousand) in case of 2-stroke petrol OBM.

7. Applications.— The owner of the fishing vessel/canoe shall apply to Directorate of Fisheries, Panaji with all the details as required by Directorate of Fisheries through the BDO of respective taluka for the purpose of availing the benefit of subsidy. The application form shall be available in respective Block Development Office (BDO), Village Panchayats and Head Office, Panaji.

8. Budget.— The required Budget provision shall be provided by Directorate of Fisheries under the Budget Head: 2405—Fisheries; 103 —Marine Fisheries; 09—Financial Assistance for construction, purchase of outboard motors(P)(A); 52—Machinery & Equipment; under Demand No. 66.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and in supersession of the Government Notification No. OSD/RRVS/60/73 dated 16-4-1974, published in the Official Gazette, Series I No. 8 dated 23-5-1974, the Governor of Goa hereby makes the following rules to regulate the recruitment to the Goa General Service, Group 'B', Gazetted posts, in the Goa Gazetteer Department, Government of Goa, namely:—

1. Short title, application and commencement.— (1) These rules may be called the Government of Goa, Goa Gazetteer Department, Group 'B', Gazetted posts, Recruitment Rules, 2013.

(2) They shall apply to the posts specified in column (2) of the Schedule to these rules (hereinafter called as the "said Schedule").

(3) They shall come into force from the date of their publication in the Official Gazette.

2. Number, classification and scale of pay.— The number of posts, classification of the said posts and the scale of pay attached thereto shall be as specified in columns (3) to (5) of the said Schedule:

Provided that the Government may vary the number of posts specified in column (3) of the said Schedule from time to time subject to exigencies of work.

3. Method of recruitment, age limit and other qualifications.— The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns (6) to (14) of the said Schedule. 4. *Disqualification.*— No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.— Where, the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Goa Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.— Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and other special categories of persons in accordance with the orders issued by the Government from time to time in that regard.

These rules are issued in consultation, with the Goa Public Service Commission conveyed vide their letters No. COM/II/ /13/23(1)/2013/15 and No. COM/II/13/ /23(2)/2013/16 both dated 1-4-2013.

amend the Goa (Appointment to the post Residents in the Goa Medical College) Rules, 1998, as follows, namely:—

1. Short title and commencement.— (1) These rules may be called the Goa (Appointment to the post Residents in the Goa Medical College) (Second Amendment) Rules, 2013.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of rule 7.— In rule 7 of the Goa (Appointment to the post Residents in the Goa Medical College) Rules, 1998, after clause (f), the following clauses shall be inserted, namely:—

"(g) The female Senior Resident may be granted Maternity Leave for a maximum period of 180 days without pay, only once during the period of her tenure;

(h) During the period any female Senior Resident is on Maternity Leave, the locum post may be filled up by appointing a candidate possessing requisite qualifications as specified in rule 4 or rule 5, as the case may be, so as to ensure smooth functioning of the Department;

(*i*) The concerned female Senior Resident availing Maternity Leave shall work for an extra period equivalent to the period of Maternity Leave availed by her, after completion of three years of Senior Residency, in order to be eligible to get three years teaching experience."
