Notification

S.O. — In pursuance of the provisions of clause (c) of sub-section (2) of section 43D of the Government of Union Territories Act, 1963, inserted by the Government of Union Territories (Amendment) Act, 1976 (No. 86 of 1976), the following Order made by the Election Commission is hereby published: —

Order

Whereas under clause (a) of sub-section (2) of section 43D of the Government of Union Territories Act, 1963, inserted by the Government of Union Territories (Amendment) Act, 1976, the proposal of the Election Commission to reserve

1 — Pernem Assembly constituency (as delimited by the Delimitation Commission under section 9 of the Delimitation Act, 1972, in its Order No. 13 of 15 April, 1974 and published in the extraordinary issue of the Gazette of India, Part II Section 3(ii) dated 27 April, 1974) was published in the Gazette of India and in the Official Gazette of the Union Territory of Goa, Daman and Diu on 30 September, 1976;

And whereas, 30 October 1976 was specified as the date on or after which the proposal would be further considered by the Commission;

And whereas all objections and suggestions received in relation to the said proposal on or before the date specified have been considered by the Commission;

The Commission hereby determines that: —

(1) On the basis of the latest census figures and having regard to the provisions of sub-section (5) of section 3 of the Government of Union Territories Act, 1963, the number of seats to be reserved for the Scheduled Castes in the Legislative Assembly of the Union Territory of Goa, Daman and Diu shall be one; and

(2) 1 — Pernem assembly constituency as delimited by the Delimitation Commission under section 9 of the Delimitation Act, 1972, in its Order No. 13 of 15 April, 1974, shall be reserved for the Scheduled Castes.
